**ACT** 

further to amend the Tripura Municipal Act, 1994

WHEREAS, it is considered necessary to make certain changes in the number of Members in the Standing Committees of different Municipalities for effective implementation of the respective provisions of the Tripura Municipal Act, 1994;

Be it enacted by the Tripura Legislative Assembly in the seventy-fourth year of the Republic of India as follows:-

- 1.Short Title and Commencement:
- 1. This Act may be called The Tripura Municipal (8<sup>th</sup> Amendment) Act, 2022.
- 2.It shall come into force from the date of its publication in the Tripura Gazette.

2.Amendment of Section 16:

In the Tripura Municipal Act, 1994, in Section 16, in sub-section (2) for clause(a), the following clause shall be substituted, namely :-

- "(a)(i) in the case of Municipal Corporation, ten elected members;
  - (ii) in the case of Municipal Council, not exceeding eight elected members; and
- (iii) in the case of Nagar Panchayat, not exceeding six elected members; and"
