Sub:-Appointment to the post of Chairperson of the Real Estate Regulatory Authority for the State of Tripura

As per the provisions of the Real Estate (Regulations & Development) Act, 2016, there will be inter alia a Chairperson of the Real Estate Regulatory Authority. The service conditions, powers, appointment etc will be as provided in Chapter-V of Real Estate (Regulations & Development) Act, 2016 as well as Chapter-Viii the Tripura Real Estate (Regulation & Development) (General) Rules, 2017.

2. As per Section 22 of the Real Estate (Regulations & Development) Act, 2016, the qualifications of Chairperson of the Authority are as follows:-

2.1 The Chairperson of the Authority shall be appointed from amongst persons having adequate knowledge of and professional experience of at least twenty years in urban development, housing, real estate development, infrastructure, economics and technical experts from relevant fields, planning, law, commerce, accountancy, industry, management, social service, public affairs or administration.

2.2 Further, a person who is, or has been, in the service of the State Government shall not be appointed as a Chairperson unless such person has held the post of Additional Secretary to the Central Government or any equivalent post in the Central Government or State Government.

3. The interested officers/persons may apply as per the enclosed proforma. The applicants who are in Government service may send their applications only through the proper channel. Incomplete applications will not be accepted.

4. All details of eligibility, as given in the application, should be in conformity with the provisions of Chapter V of Real Estate (Regulations & Development) Act, 2016 and Chapter VIII of the Real Estate Regulatory Authority for State of Tripura as per the provisions of the Real Estate (Regulation & Development) Act, 2016 and the Tripura Real Estate (Regulation & Development) (General) Rules, 2017.
